Any benefit amount requested above guaranteed issue will require Evidence of Insurability.</p>	<p>This plan will pay you disability benefits when you are unable to work due to <b>Non-Occupational sickness or injury</b>. You have the option to choose the length of the elimination period (initial period in which benefits are not paid), the length of the benefit period (number of weeks you will receive benefits after elimination period is met) and the amount of the benefit* you will receive.</p> <p>*The Guaranteed Issue benefit is \$1,500 per month. Any benefit amount requested above guaranteed issue will require Evidence of Insurability.</p>

<p>This plan pays cash benefits for the following occurrences: <b>Hospital Confinement, Hospital Admission, Intensive Care, and Intermediate Hospital Step-Down Unit.</b></p>			

## Accident

24 hour accident coverage. In the event of a covered accident, the plan pays cash benefits fast to help with the costs associated with out-of-pocket expenses and bills – expenses major medical may not take care of.

**\*\*Your deadline to enroll is 30 days after your date of hire. Benefits will be effective on the 1<sup>st</sup> of the month following 30 days of hire, provided enrollment is completed timely.**
